RULES OF SCHOLARSHIP

- 1 The Scholarship will be known as the Hurstville & Rockdale Friendly Society Scholarships.
- 2 The Object of the Scholarships will be to assist Members and dependants of Members of the Society to continue their education at a tertiary institution.
- 3 Eligible applicants for these scholarships will be members or dependants of members. Applicants must be under the age of twenty-five years, who are undertaking full time study at an Australian University.
- 4 Applicants: Application on the official form must be lodged with the Administration Manager.
- 5 Awards will be determined by using the Australian Tertiary Admission Ranking. However The Scholarship Committee may exercise discretion to take other factors, including disadvantage, into account in allocating the scholarships.
- 6 The Tertiary Scholarship will be tenable at any recognised Australian University. A Tertiary Scholarship will have a tenure of a period of time as initially enrolled in as an undergraduate, and carry an allowance of \$500 per annum, payable at the commencement of Semester 1, on verification of enrolment. **Scholarships will be held subject to satisfactory progress as indicated by examination results.** A Scholarship may be held in conjunction with any other scholarship or award with the approval of the Scholarship Committee.
- 7 Administration of these scholarships will be vested in the Board of Directors of the Society. Decisions of the Board of Directors will be final. Hurstville & Rockdale Friendly Society Ltd may, at its discretion, vary the Conditions of the award of these scholarships.
